

B106.7 's "USHER WINNING WEEKEND" CONTEST

OFFICIAL RULES

The Station will conduct the **B106.7 "USHER WINNING WEEKEND"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, , age eighteen (18) or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last **30 Days** or a prize valued at \$500 or more in the last **30 days**, and whose immediate family members or household members have not won a prize from the Station in the last **30 days** or a prize valued at \$500 or more in the **30 days**

Void where prohibited by law. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Contest Period. The Contest entry period will begin at **6 AM EST on 11 October 2024** and will run through **3PM on OCTOBER 14 2024** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

- (a) Visit the Station's FB page a B106.7/WTCB during the Contest Period;
- (b) Comment on the facebook and Instagram pages

Winners must follow the instructions on Facebook and/or Instagram to go in the running to win.

- 1) Must like B106.7 on Facebook and/or Instagram
- 2) Must share the post
- 3) Must comment with their favorite Usher song

One winner from Facebook and one from Instagram will be selected on Monday, October 14, 2024, to win a pair of tickets to see Usher in Charlotte.

- (c) Include in the comment: #contest.

Any entry comments that are indecent, lewd, offensive, defamatory, contain profanities, or are in any way in bad taste or contain material that may infringe or violate any laws or anyone's rights, as determined in the sole discretion of the Station, may be disqualified. Entry comments that are removed and/or blocked by Station and/or by B1067/WTCB will be deemed not entered in the Contest.

This Contest is in no way sponsored, endorsed, administered by, or associated with B1067/WTCB's Facebook and Instagram. By submission of an entry, an entrant releases B1067/WTCB Facebook] [Instagram from any responsibility or liability for the Contest's administration, prizes, or promotion. An entrant is providing entry information to the Station and not to [Facebook][Instagram].

3. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize.
